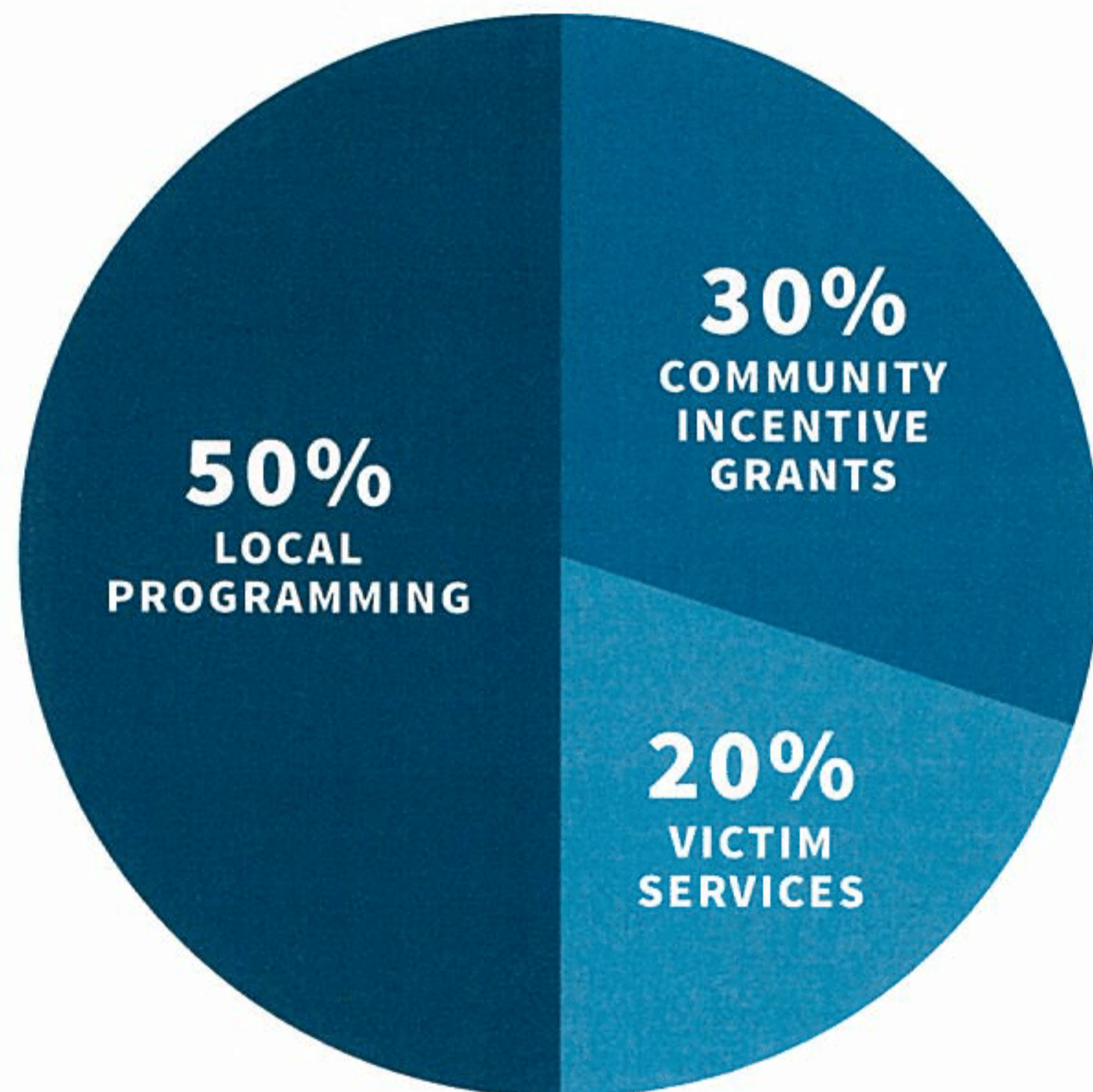


# CRIMINAL JUSTICE REFORM

IMPROVING PUBLIC SAFETY • SUPPORTING VICTIMS • CHANGING LIVES

In June 2017, Republicans, Democrats and Independents came together to rethink Louisiana’s criminal justice system. This bipartisan effort that Gov. Edwards signed into law is anticipated to save the state more than **\$262 million** over the next decade. In addition, the reforms mandate that 70 percent of the savings be reinvested into programs to **reduce recidivism, support victims** and **improve public safety**. In Fiscal Year 2017-2018, the state saved **\$12.2 million** as a direct result of this legislation. This money is being redirected toward Community Incentive Grants, Victim Services and Reinvestment and Reentry Programs.
